**Carpentry / Lighting:** The stairway railing and lighting for stair and basement have been completed. A scaffold is up and Jim Yourno will soon have all the LED's installed.

Oil change: Scheduled and in progress.

**Truck Sales:** 514 and 512 – Will be sold. Bromley Mt. and two other outlets have been contacted. They are going to list them for sale.

**Property:** Fred Marifield weed-whacked the property

**Fuel Access:** Greg Serio is working on talking with the Town Board about the issue of getting fuel from the Town. Sam plans on speaking with Pat Kennedy, Councilperson, and Bill Hribar, Highway Superintendent, to see if we can get an agreement with the Town Board. The Town has a new system needing a code to pump the fuel.

**Budget:** The budget hearing will be Thursday October 16<sup>th</sup> at 6:30 pm, before the regular board meeting. The state has allowed a 2.7% increase in the tax for the District. The Commissioner's approved the proposed budget, not to exceed the Tax Cap.
