

The Town of Otsego Town Board held a Special Monthly Meeting on the 16th day of December 2025 starting at 4:00 PM at the Town Office Building in Fly Creek, NY.

Supervisor Feury called the meeting to order.

Everyone was given a draft Organizational Form provided by town Attorney Will Green to review before the Organizational Meeting to be scheduled in January. The Town Board discussed possible ways the form might be tailored for the Town of Otsego.

MOTION by Councilperson Kennedy, seconded by Councilperson Dalton to appoint Jeff Banner and Alex Nirenberg to the alternate vacancy positions on the Planning Board.

A Friendly MOTION was offered by Councilperson Kjolhede, to also re-appoint Tom Huntsman (to a Term that will Expire on12/31/32) and Matthew Glynn (to a Term that will Expire on 12/31/29) to the Planning Board.

MOTION CARRIED: All were in favor.

MOTION by Councilperson Kennedy, seconded by Councilperson Dalton, to sign the 284-form limiting the Town Hwy Superintendent 2025 year-end Expenditures to \$286,197.61.

MOTION CARRIED: All were in favor. Supervisor to obtain signature of Highway Superintendent on both copies and send copy to County Highway Department.

MOTION by Councilperson Kennedy, seconded by Councilperson Dalton, to schedule a Public Hearing for February 11<sup>th</sup> 2026 to hear Public Comment on the Proposed Local Law #1, The Solar Law and to submit the Solar Law Draft and SEQR to the County Planning Department for review and comment .

MOTION CARRIED: All were in favor.

MOTION by Councilperson Kennedy, seconded by Councilperson Craig, to amend the MOTION offered by Councilperson Kennedy, and Councilperson Kjolhede, at the December 10<sup>th</sup> meeting, to purchase a Ford F-350 truck for \$85,204.17 to read to purchase the F-350 truck but not to exceed \$87,000.00 and the existing light bar is to be removed and either sold or reused on one of the town’s existing trucks.

MOTION CARRIED: All were in favor.

MOTION by Councilperson Kennedy, seconded by, Councilperson, Dalton, to purchase a sweeper not to exceed \$26,000.00 contingent on Councilperson elect Jay Bosley and Supervisor Feury’s recommendation after meeting with Hwy Superintendent Hribar, and getting an understanding how the sweeper works and whether it could potentially damage whatever truck it is attached to.

MOTION CARRIED: Feury, Kennedy, Dalton and Kjolhede were in favor. Craig opposed.
