Old Business:

Electronic Sign

On May 20th Hoskins and Kehoe have a meeting on 5-20-25 with the Zoning board about approving the erection of a new sign. At this point estimates are between \$38 and \$44 thousand dollars.

Mr Serio reminded the commissioners that the purchase has to go out to bid with a legal publication. Specifications are to be available for reviewing and sending to those requesting them. It is a state law that anything over \$20,000. has to go out for bid.

He also reminded the commissioners to get a good warrantee, and servicing and have the contract with someone agreeable to NYS laws. The insurance company should also be advised of the installation. An outside TV was also mentioned as a less expensive alternative.

Policies -

The proposed policies given by Mr Serio were:

Harassment Policy and Statement Investment and Deposits Policy Workplace Violence Policy and Procedure Procurement and Purchasing Policy Code of Ethics

He mentioned that at this time we do not have "Best Value" for deciding the criteria in purchases which he suggested we adopt.

He mentioned "Sourcewell", a nationwide vendor from Minnesota that cannot be used for "best value". Existing approved policies were mentioned: Public Comment and Hearing Policy and a Harassment Policy will be given to all members and Commissioners. .

The District Secretary and Treasurer and Fire Company members are to have their copy of the Harassment policy in their own file and it is to be kept for seven (7) years

The Junior Firefighter Policy has to be signed by the parents of those under 18 years of age.

At the next meeting, Wednesday, June 18, 2025, the policies will be reviewed.

EVOC -

The training will be Saturday from 8 til 2 and on Sunday. There are 30 people signed up to take the class.

Black Stain -

It is not thought to be from the roof.

Truck Inspection-

It has been done.

Mini Split Roof -

Dan Evans to give a quote

LED Replacement -

NYSEG is to give us free fixtures. Jim Yourno will do the electrical work for \$600.00 – there are 180 tubes in the building.

Issue with Mail -

The Company was advised that any mail that comes to the District PO Box 218 will be opened before it is given to the company if it has been addressed to the Company but with the PO Box that the district pays for. The Company Box PO is 89.

Public Comment -

Shirley Dickison about the requirement that the Chief must take training before they can be approved by the Commissioners. A policy could be implemented that it is a condition of appointment.
